

# Support SARRC with the Individual Tuition Tax Credit

## What is the Arizona Individual Tuition Tax Credit?

A tuition credit program, established in 1997, allows Arizonans to redirect their tax dollars to help children have a choice in education. You can donate your state taxes to benefit children who are currently enrolled in a private school that qualifies for a scholarship from this credit.

## Do I qualify to receive a tax credit?

All Arizona taxpayers qualify for a tax credit up to \$1,107 for single taxpayers or \$2,213 for married couples filing jointly. You do not need to have a child enrolled in a school to receive the credit. You can give to multiple tax credits (public school, working poor, other private school) and still get the credit as long as it does not exceed your tax liability.



## How will my donation be used?

Your dollars will be used to supplement the tuition of a child at SARRC's Community School. Our Community School is an inclusive preschool program that provides intensive, ABA-based programming for children with autism spectrum disorder and high-quality early childhood education for typically developing children. All children receive the benefits of highly trained SARRC classroom therapists within a 4:1 teacher-to-student ratio.

Children with ASD receive 1:1 interventions in the classroom, parental training sessions conducted in the family's home and in the community, and program supervision from a Board Certified Behavior Analyst (BCBA).
